

### Health Guarantee

South Fork Boxers has made every effort to provide you with a happy, healthy puppy. We guarantee this puppy is purebred with AKC & CKC registration papers. We guarantee that all vaccines and worm medicines are current as stated in the health records provided. We require the purchaser to have this puppy examined by a licensed veterinarian of their choice within 48 hours of taking possession of this puppy, or this guarantee will be null and void. If this puppy is found to have a life threatening hereditary congenital defect at this exam, the breeder must be notified IMMEDIATELY. At this time, the breeder can and may require a secondary exam from a different DVM (AT NO EXPENSE TO THE BREEDER). These visits, lab work, and findings will need to be properly documented, signed by examining Physician and forwarded directly to the breeder. A replacement puppy of same sex, and equal value will be given (NO MONEY WILL BE REFUNDED AT ANY TIME), after the purchased puppy is returned to the Breeder along with all Kennel Club registration papers (AT NO EXPENSE TO THE BREEDER). Breeder will not be responsible for any veterinarian bills incurred by the Purchaser.

This guarantee does not include injuries, fleas, mites, cocci, giardia, or any other intestinal worms/parasites, as they are common in dogs and puppies. Breeder will not be responsible for Parvo, Distemper or Carnona Virus after 24 hours of the sale, as these are highly contagious diseases and can be contracted immediately after leaving the Breeder. There is no guarantee on eye sight or hearing because puppies are not examined by a specialist. Breeder will not be responsible for health problems that are detected after this initial DVM visit, except where stated in this contract. Breeder also reserves the right to refuse the replacement of any puppy returned for temperament, hip problems, or any other medical issues if neglect or abuse by owner is suspected. This includes but is not limited to over feeding, under feeding, excessive exercise, and improper socialization.

This puppy is guaranteed for 1 year. In the unlikely event of this puppy's death in the first year, due to a hereditary congenital defect, the Purchaser will be entitled to a replacement puppy of equal value (NO MONEY WILL BE REFUNDED AT ANY TIME) when available (usually within 12 months). A statement from a licensed veterinarian confirming cause of death along with lab work is required before any action will be taken by the Breeder. If cause is unknown, an autopsy is required. The Breeder will not be responsible for any veterinarian bills incurred by the Purchaser.

Your puppy has been on a vaccination and de-worming schedule here and is up to date. These records will be provided to you. Please take these records to your Vet, as it is important to continue with these vaccines and worm treatments after you take your new Boxer home. Please do not forget the annual booster after that. You, the Purchaser, agree to insure your puppies' good health and to keep our guarantee in effect by taking good care of the puppy, providing good food, good housing, and medical care. Please remember that puppies are babies too, and need lots of love and care.

If puppy/dog is purchased under the spay/neuter agreement, please read carefully and sign the spay/neuter contract provided below.

This guarantee is valid only for the original purchaser of the puppy from My Boxer Kings. If the dog is transferred to another owner this contract is null and void.

The Breeder makes no guarantees, expressed or implied, under this contract except as stated in these pages. UNDER NO CIRCUMSTANCE OF ANY KIND WILL MONEY (INCLUDING PUPPY/DOG AMOUNT OR SHIPPING FEES). BE REFUNDED. UNDER NO CIRCUMSTANCE IS THE BREEDER RESPONSIBLE FOR ANY VET BILLS INCURRED AFTER TIME OF TRANSFER.

Purchaser releases South Fork Boxers, the King's and their estate from any and all liabilities and/or damages by fault of this dog after the time of sale. These damages include, but are not limited to, destruction of property/or physical damage to any person or group of people.

Purchaser agrees that he/she fully understands this contract, and that this contract is under the jurisdiction of the state of Tennessee, in the county of Scott. It is agreed that the place of venue shall be in Scott County, Tennessee.
